## **Student Satisfaction Statistics:**

In 2018, ALU collected the following results (what is provided below is the available data from that cycle; no data is available for other programs due to lack of responses from students in that program or no enrollments in that program).

**For the Juris Doctor program:** 29 students took the survey out of 119 students whom the survey was distributed to. 27 out of 27 students indicated they achieved or will achieve the goals that they had starting the course or program (100%), 23 out of 25 students indicated that they would recommend their studies to a friend (92.6%), and 23 out of 25 students indicated that all things considered, they were satisfied with their studies at ALU (92.6%).

**For the Doctor of Business Administration program:** 1 student took the survey out of 4 students whom the survey was distributed to (the DBA is a new program). That student selected responses indicating that the student achieved or will achieve the goals that the student had starting the course or program, that the student would recommend their studies to a friend, and that all things considered, the student was satisfied with their studies at ALU [100% positive].

**For the Master of Science in Law program:** 2 students took the survey out of 22 students whom the survey was distributed to. Those two students selected responses indicating that they achieved or will achieve the goals that they had starting the course or program, that they would recommend their studies to a friend, and that all things considered, they were satisfied with their studies at ALU [100% positive].

**For the Master in Business Administration program:** 1 student took the survey out of 2 students whom the survey was distributed to. That student selected responses indicating that the student achieved or will achieve the goals that the student had starting the course or program, that the student would recommend their studies to a friend, and that all things considered, the student was satisfied with their studies at ALU [100% positive].

**For the Bachelor of Science in Legal Studies program:** 2 students took the survey out of 19 students whom the survey was distributed to. Those two students selected responses indicating that they achieved or will achieve the goals that they had starting the course or program, that they would recommend their studies to a friend, and that all things considered, they were satisfied with their studies at ALU [100% positive].

**For the Associate of Science in Business Administration program:** 1 student took the survey out of 1 student whom the survey was distributed to. That student selected responses indicating that the student achieved or will achieve the goals that the student had starting the course or program, that the student would recommend their studies to a friend, and that all things considered, the student was satisfied with their studies at ALU [100% positive].
